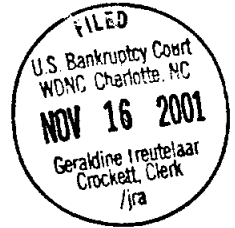

JUDGMENT ENTERED ON NOV 16 2001

The undersigned, based on the application by the Standing Trustee for authority to carry over expenses from fiscal year 2001 to fiscal year 2002 as regards the Chapter 13 office for the Wilkesboro and Shelby divisions, find as follows:

1. The Trustee has estimated his normal operating expenses at \$105,000 per month, based on historic data.

2. The Trustee believes that it is in the best interest of the operation of the office to carry over an amount sufficient to cover the next month's expenses as well as at least one additional month's worth of expenses for the purpose of having a sufficient reserve, for a total of \$210,000 in this category.

3. The Trustee has already accumulated the following reserves in fiscal year 2001:

Computer upgrade reserve (prior)	\$49,404
Computer upgrade reserve (2001)	3,600
Renovations	5,500
Total	<u>111,508</u>

BASE ON THE FOREGOING and representations of the Trustee, the Court finds both as a matter of administrative efficiency and the best interests of debtors and creditors involved in the operation of the Chapter 13 Office that it is necessary and prudent to carry over all these sums into the fiscal year 2002.


THEREFORE IT IS ORDERED, ADJUDGED AND DECREED that the Standing Trustee for the Wilkesboro and Shelby divisions for the Chapter 13 office is allowed a carry over from fiscal year 2001 to fiscal year 2002 up to \$321,508 from funds presently on hand for the indicated administrative expenses of the office.
