

## Chapter 13 Plan – Chapter 13 Plan Amendments Effective October 9, 2018

### Background:

In the past, attorneys and their staff have had to docket both a Chapter 13 plan, and subsequently, a “Plan Motions Event” for statistical reporting purposes. In December 2017, the Chapter 13 Plan underwent an overhaul, including a modified docket event in CM/ECF.

Beginning October 9, 2018, attorneys and their staff will see one or more additional screens if “requests” are included when docketing the Chapter 13 Plan event. The plan filer will choose the number of “requests” pursuant to the details of the plan. For example, if the plan includes three valuations and two lien avoidances, the check boxes “Request Valuation...[Part 3.2] and Request for lien avoidance [Part 3.4] will be selected. On the next screen, the “three” radio button would be selected for the three valuations. On the following screen, the “two” radio button would be chosen for two lien avoidances.

Additionally, attorneys and their staff will no longer have to docket the “Plan Motions Event,” and this selection will no longer be accessible in CM/ECF.

### ECF Event: Bankruptcy – Other – Plan

Select applicable requests, or “none”, dependent on the Ch. 13 Plan - LF 4 being filed. Click Next.

Select any of the following requests that are included with the Chapter 13 Plan, or check the box indicating None. :

- Request for valuation of security, payment of fully secured claims, and modification of undersecured claims [Part 3.2]
- Request for lien avoidance [Part 3.4]
- Request that the stay under 11 U.S.C. 362(a) be terminated as to collateral surrendered in the plan [Part 3.5]
- Request for assumption of executory contracts and/or unexpired leases [Part 6]
- None
