**Order Exempting Chapter 7 and Chapter 13 Trustees from PACER Charges**

The United States Bankruptcy Court for the Western District of North Carolina implemented the CM/ECF system on March 5, 2001. As a result, access to Court records is available only through the use of a PACER account. The Court believes that all Chapter 13 trustees and all Chapter 7 panel trustees should be exempt from PACER charges for all trustee-related use.

It is therefore ORDERED that the following Chapter 13 and Chapter 7 trustees are exempt from PACER charges for all trustee-related use:


