- 4. Do not put the call on "hold," as that may cause others to hear a pre-recorded message;
- 5. Do **not** accept another call during your meeting window;
- 6. After dialing in, mute your phone until the case is called to minimize disruptions: landlines may mute and unmute by pressing
 - *6; cell phones may be muted using the phone's screen interface. You need not say anything until your name is called.
- 7. If the call is dropped, simply dial back in.
- 8. If the trustee or BA must mute all callers due to a disruption, you must press *6 to unmute your line when your name is called.
