Program Overview

Judge Bell will share his professional path and his expectations for his courtroom. He will take questions from the audience. Attendees should leave the program feeling as though they've been introduced to Judge Bell and are better prepared for federal practice.

Judge Kenneth D. Bell received his judicial commission on June 12, 2019, and is the newest judge on the U.S. District Court for the Western District of North Carolina. Judge Bell earned his B.A. from Wake Forest University and his J.D. from the Wake Forest University School of Law. He served in the W.D.N.C. as an Assistant U.S. Attorney for eight years and then as First Assistant U.S. Attorney for ten years. He then went into private practice, as a partner at Mayer Brown, Hunton & Williams and McGuireWoods. On April 10, 2018, President Trump announced his intention to nominate Bell to serve as a United States District Judge of the U.S. District Court for the W.D.N.C.; he was nominated to the seat vacated by Judge Voorhees, who has been on senior status since August 31, 2017. Judge Bell's nomination was confirmed by the Senate on May 22, 2019.
