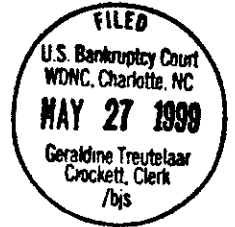

ORDER



It appearing to the Court that the District Court has rearranged the Divisions of the District for its efficient administration of justice; that rearrangement of the Divisions for the Bankruptcy Court is not necessary at this time; and that the Bankruptcy Court should maintain its Divisions as they are presently arranged.

It is THEREFORE ORDERED that the Divisions of the Bankruptcy Court for the Western District of North Carolina shall consist of the following:

CHARLOTTE DIVISION: Anson, Gaston, Mecklenburg and Union.

SHELBY DIVISION: Burke, Cleveland, McDowell, Polk and Rutherford.

STATESVILLE DIVISION: Alexander, Alleghany, Ashe, Caldwell, Catawba, Iredell, Lincoln, Watauga and Wilkes.


BRYSON CITY DIVISION: Cherokee, Clay, Graham, Jackson, Macon and Swain.




